**DANCE CAMP RELEASE: Session 1**

In consideration of the consent to enter upon the premises of Soyuzivka Heritage Center and Roma Pryma Bohachevsky Ukrainian Dance Camp, located at the Soyuzivka Heritage Center, Kerhonkson, New York during the periods from July 23, 2017 through and including August 5, 2017 and in further consideration of receiving permission to participate in the Workshop events as student, workshop enrollee, counselor and/or participant, or in any other capacity, the receipt of such permission being hereby acknowledged and the sufficiency of such consideration being hereby consented, each of the undersigned hereby releases all members of Roma Pryma Bohachevsky Dance Academy and U.C.D.A.,Inc, including without limitation its counselors, trainers, dancers, staff, administrators, officers, directors, employees, servants, and agents, of and from any and all liability, claims, suits, demands and causes of action whatsoever, arising out of or related to any loss, damage or injury, including death, that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned, while in, on, or upon the premises, grounds, properties, or otherwise participating in any such Soyuzivka Heritage Center and Roma Pryma Bohachevsky Dance Academy event, or any other activity sanctioned by or under the control or supervision of the Roma Pryma Bohachevsky Dance Academy, or *en route* to or from these premises or any other premises under the control or supervision of Soyuzivka Heritage Center and Roma Pryma Bohachevsky Dance Academy. In the event participate leaves the premises, Roma Pryma Bohachevsky Dance Academy and UCDA, Inc. shall not be responsible in any manner.

Each of the undersigned being duly aware of the risks and hazards inherent upon entering upon said premises and/or in participating in any activity, event, functions, training, or other activities at said premises or as a part of said workshop, hereby elects voluntarily to enter upon said premises and participate in any such event, knowing their present conditions, knowing that said conditions are and may become more hazardous or dangerous during the time that each of the undersigned is upon the said premises, and the associated risks involved therewith. The undersigned hereby specifically acknowledges that certain activities may be inherently dangerous. Each of the undersigned hereby **voluntarily assumes all risks** of loss, damage, and personal injury, including death, that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned while in, on or upon said premises or participation in any camp event or activity.

This release shall be binding upon the undersigned, his/her guardians, heirs, next of kin, executors, administrators and personal representatives of each of the undersigned. The parties hereto further explicitly agree and acknowledge that any action or suit brought for injuries, damage or death of the undersigned must be brought and venued in the New York State Supreme Court of Ulster County.

Should any such camper or participant of the Roma Pryma Bohachevsky Dance Academy be under the age of 18 years old, the parents or legal guardians of the minor do hereby expressly stipulate, consent and agree, in consideration of the foregoing, on behalf of their minor child, to each and every term of this Academy Release. This Academy Release contains the entire agreement between the parties hereto, and the terms of this Academy Release may not be changed orally, are contractual and not a mere recital. The undersigned further states that he/she has carefully read each of the terms of this Academy Release, understands the English language, knows the contents thereof, voluntarily signs the same of his/her own free act, is over the age of eighteen(18) years, and is of sound mind.
